A. Resolution Approving the Intermunicipal Transfer of Pennsylvania Liquor License Number R-11631

### 5. PUBLIC COMMENT

Ed Krusman, 20 Aberdeen Drive, said he is new to his development and he is wondering if the new development on Van Buren Road was already approved. Colver said it is working its way through the Township Planning Commission now. Once it makes its way through planning, they will make recommendations to this Board. Krusman asked about the traffic from the development, will there be traffic signals, etc. Colver said that will all be discussed through the planning process.

Wayne Conrad, Moor Drive, said he saw a "for sale" sign on the farmland along Van Buren Road and Newlins Mill Road and asked for an update on that sale. Colver said we haven't seen any formal application for the property yet. Colver said over the past three to five years

we've seen three to four interested in it.

### 6. REPORTS

### **Solicitor**

Bruno had an extension agreement for Parkview Estates, Phase 7, requesting time until June 30, 2017 to complete their improvements. Bruno said the motion would be to authorize the Chairman to sign the extension agreement.

Charles Diefenderfer, 2918 Hay Terrace, said awhile ago the State was trolling deadlines for extensions. Has this been extended. Bruno said no.

### Township Manager

Christman said at our last meeting the Board approved an agreement with the Lehigh

Valley Health Network for them to conduct a metering study related to their project in Lower Nazareth Township. Christman said he met with Jeff Cantwell this past Friday and they will begin the study the week of March 13th. You may be seeing a red truck driving around our township while conducting the study and they will be accompanied by our Sewer Department staff. Christman said he will put the information on the website so residents are also aware of the study. The study will take one year to complete.

### Police Chief

Chief Palmer had one legal matter for executive session.

# Supervisors

Colver said the Fire Department received the final plans for the two new trucks and they will be reviewing them this week and expect to be able to sign off by the end of the week. Delivery should still be on for October.

Colver said the Fire Department is also planning to host the Pink Heals Tour for Cancer Awareness on July 15, 2017. It is a nationwide tour and they intend to host it at the High School due to the size of the event.

Ed Krusman asked if the two new trucks are replacement trucks or new. Colver said we are replacing two trucks and he gave Mr. Krusman the history on the sale of existing trucks and the financing that has already taken place for the new vehicles.

Supervisor Panella said this past Saturday she attended an Eagle Scout Court of Honor for Nicholas Hamel. His project was to put half-mile markers along our 12-mile bike path and he gave the Fire Department/Police Department and Suburban EMS the coordinates for them so they can use them, in emergency situations in the future.
